Ilifornia standards for ozone, carbon monoxide (except Lake Tahoe), sulfur dioxide (1-hour and 24-ur), nitrogen dioxide, suspended particulate matter - PM10, and visibility reducing particles are values at are not to be exceeded. The standards for sulfates, Lake Tahoe carbon monoxide, lead, hydrogen lfide, and vinyl chloride are not to be equaled or exceeded. If the standard is for a 1-hour, 8-hour or 24-ur average (i.e., all standards except for lead and the PM10 annual standard), then some sasurements may be excluded. In particular, measurements are excluded that ARB determines would cur less than once per year on the average. The Lake Tahoe CO standard is 6.0 ppm, a level one-half anational standard and two-thirds the state standard.

itional standards shown are the "primary standards" designed to protect public health. National andards other than for ozone, particulates and those based on annual averages are not to be exceeded are than once a year. The 1-hour ozone standard is attained if, during the most recent three-year riod, the average number of days per year with maximum hourly concentrations above the standard is ual to or less than one. The 8-hour ozone standard is attained when the 3-year average of the 4th shest daily concentrations is 0.070 ppm (70 ppb) or less. The 24-hour PM10 standard is attained when 3-year average of the 99th percentile of monitored concentrations is less than 150 μg/m3. The 24-ur PM2.5 standard is attained when the 3-year average of 98th percentiles is less than 35 μg/m3.

October 1, 2015, the national 8-hour ozone primary and secondary standards were lowered from 175 to 0.070 ppm. An area will meet the standard if the fourth-highest maximum daily 8-hour ozone ncentration per year, averaged over three years, is equal to or less than 0.070 ppm. EPA will make commendations on attainment designations by October 1, 2016, and issue final designations October 1, 17. Nonattainment areas will have until 2020 to late 2037 to meet the health standard, with attainment tes varying based on the ozone level in the area.

e national 1-hour ozone standard was revoked by U.S. EPA on June 15, 2005.

April 1998, the Bay Area was redesignated to attainment for the national 8-hour carbon monoxide andard.

June 2002, CARB established new annual standards for PM2.5 and PM10.

atewide VRP Standard (except Lake Tahoe Air Basin): Particles in sufficient amount to produce an tinction coefficient of 0.23 per kilometer when the relative humidity is less than 70 percent. This andard is intended to limit the frequency and severity of visibility impairment due to regional haze and is uivalent to a 10-mile nominal visual range.

e 8-hour CA ozone standard was approved by the Air Resources Board on April 28, 2005 and became ective on May 17, 2006.

January 9, 2013, EPA issued a final rule (https://www.federalregister.gov/articles/2013/01/09/2013-170/determination-of-attainment-for-the-san-francisco-bay-area-nonattainment-area-for-the-2006-e%20) to determine that the Bay Area attains the 24-hour PM2.5 national standard. This EPA rule spends key SIP requirements as long as monitoring data continues to show that the Bay Area attains ∋ standard. Despite this EPA action, the Bay Area will continue to be designated as "non-attainment" for ∋ national 24-hour PM2.5 standard until such time as the Air District submits a "redesignation request" d a "maintenance plan" to EPA, and EPA approves the proposed redesignation.

I June 2, 2010, the U.S. EPA established a new 1-hour SO2 standard, effective August 23, 2010, which based on the 3-year average of the annual 99th percentile of 1-hour daily maximum concentrations. e existing 0.030 ppm annual and 0.14 ppm 24-hour SO2 NAAQS however must continue to be used til one year following U.S. EPA initial designations of the new 1-hour SO2 NAAQS. EPA expects to ake designation for the Bay Area by the end of 2017.

December 2012, EPA strengthened the annual PM 2.5 National Ambient Air Quality Standards AAQS) from 15.0 to 12.0 micrograms per cubic meter (µg/m3). In December 2014, EPA issued final a designations for the 2012 primary annual PM 2.5 NAAQS. Areas designated classifiable/attainment" must continue to take steps to prevent their air quality from deteriorating to healthy levels. The effective date of this standard is April 15, 2015.
