Q&A

Q: Is the San Jose Police Department (SJPD) planning on increasing the number of officers on patrol?

A: The SJPD recruiting unit is working tirelessly to increase the number of cadets and police officers in patrol throughout the districts and City.

Q: More District 2 neighborhoods need patrols. Any plans for that?

A: As the San Jose Police Department (SJPD) works to increase the number of police officers on the street, there will continue to be a rise of patrols in District 2 and the Southern Division of the Police Department.

Q: Why is San Jose the only major California city without a police substation?

A: San Jose has a major police station that is located on 201 W. Mission Street, San Jose, CA 95110. The Southside Police Substation is currently being used as a training center for the City's Police Academy.

Q: How will an operational substation make management of the San Jose Police Department more efficient?

A: An operational substation will allow the San Jose Police Department to better manage Police Reports throughout the City. More importantly, an operational substation will help decrease response times by allowing officers to dispatch from the southern part of the City. Q: What are the roles of SJPD vehicles labeled "Community Police Officer"?

A: A Community Service Officer (CSO) provides support in crime prevention, investigation, and response where full police powers are unnecessary and assists police officers in upholding law and order. To learn more, please visit the Community Service Officer Program (CSO) website.

Q: Is there a way to volunteer with the San Jose Police Department (SJPD)?

A: The SJPD encourages residents to get involved in the multiple community services, resources, and programs the Department offers. Learn more at SJPD's <u>Community Services website</u>.

Q: How long must a cadet serve before becoming a full-fledged police officer?

A: All San Jose Police Department cadets must undergo a 26-week training program, and then serve in the field under supervision for 17 weeks. For more information, please visit the <u>San Jose Police Academy website</u>.

Q: When is the burglary unit getting more officers?

A: The San Jose Police Department is currently recruiting to strengthen the burglary unit. This process began in 2016 and is still ongoing.

Q: Will a gang task force be reinstated?

A: Since 1991, the City of San Jose has invested in the Mayor's Gang Prevention Task Force (MGPTF). MGPTF is a broad coalition composed of: local residents; city, county and state government leaders; school officials; community and faith-based organizations; and local law enforcement. The Task Force brings these diverse stakeholders together and leverages each group's expertise as part of a coordinated, interagency effort to curb gang-related activity in San Jose. Q: Can we bring back the park police?

A: The San Jose Police Department is working to increase the number of police officers on patrol throughout the City. As the number of police officers increase, there will continue to be discussions about staffing our local parks with local law enforcement.

Q: Does San Jose have a Citizen's Academy? If not, what channels can we take to start the program?

A: The City of San Jose does not have a Citizens' Police Academy, but has many resources for community members to get involved. Learn more at SJPD's <u>Community Services website</u>.

Q: How is the San Jose Police Department (SJPD) utilizing social media to assist with solving crimes and improving community relations?

A: The San Jose Police Department uses social media to share information that educates, informs, and provides resources to neighborhood residents. Social media includes using Facebook, Nextdoor, Twitter, and Instagram. Pictures, videos, and new technology have allowed the SJPD to solve and address numerous cases in the City.

Q: Do you utilize Nextdoor(App)?

A: The San Jose Police Department (SJPD) utilizes Nextdoor to share information with residents. Please do not report crime to the SJPD via Nextdoor. Q: In terms of homeless housing, are certain areas being impacted with temporary placements?

Q: What is the number of the people living in apartments and townhouses?

A: The San Jose Police Department (SJPD) does not keep records that relate to the number of townhouses or apartments in the City of San Jose. Q: What is being done about the mentally ill homeless at the old Nob Hill center at Bernal and Santa Teresa? What do we do if the homeless man proves aggressive?

A: The San Jose Police Department (SJPD) is constantly responding to and collaborating with the City's Housing Department to abate and clean up homeless encampments throughout the City. If you feel endangered by a particular homeless individual, please call 311 or 911 for emergencies.

Q: Do new officers struggle to find affordable housing?

A: Every San Jose Police Department officer has his or her own individual needs. It is impossible to tell if they are receiving or in need of affordable housing. Cadets are paid \$34.59 an hour and usually have a starting officer salary of \$87,176. If you have any further questions about new officers, please call the San Jose Police Department at (408) 277-8900.

Q: What is the plan to contain the homeless population?

A: Homelessness is a nationwide issue, and there is no one solution to solve this crisis. The San Jose Police Department (SJPD) will continue to respond to reports of homeless encampments and vagrancy. For questions about homelessness

Q: When will the new LED street lights be installed in the neighborhood on the La Colina Park Side of Cottle Road?

A: The San Jose Police Department (SJPD) does not have information about LED street light installments throughout the City of San Jose. Q: Does the new California "real ID" also function as a driver's license?

Q: Is the rise in crime related to gang activity or is it individual?

Q: What is the solution to vacate mobile homes/RV's parked illegally?

A: Due to the rising costs of housing throughout the State of California, our City has seen a rise in illegally parked mobile homes and RV's. Our community must work together to find solutions that decrease illegally parked vehicles and serve the needs of vulnerable residents.
