After several attempts to print, I ended up having to print each page separately (except for page 10 which wouldn't print at all). It seems to me that page 10 is somehow corrupted or encrypted. I ended up having to take a screen shot of page 10 and print it that way. I then inserted that page into the previously printed pages and rescanned it. Unfortunately, this new document is not as crisp as the original (your copy is pretty crisp, though) but you should be able to print it out. As you can see, I didn't reduce this copy as the maps already seemed pretty degraded.
