I, Leland Wilcox, am an authorized representative of City of San José (“**City**”) and agree to waive the confidentiality of information contained in the City’s Application for Interconnection Services previously submitted to Pacific Gas and Electric Company (“**PG&E**”) on April 30, 2020 for two Points of Interconnection at PG&E’s San José Station A. This waiver is for the limited purpose of allowing Google LLC (“**Google**”), the City, and PG&E to discuss details related to the large load that the Interconnection Application and Google’s interconnection application submitted to PG&E for electric service to the proposed Diridon locations. PG&E will not discuss the City’s Interconnection Application with Google, either orally or in writing, without the participation of the City. Any

communication regarding the City's Interconnection Application between PG&E and Google's for any purpose other than authorized herein will require the City's explicit consent in writing.
