Hi Rosalynn,

To follow up on the request for moving the Community Date. We just had our outreach meeting and Lori shared a list of all the different stakeholder, community groups, SAAG, etc meeting for Oct and there appears to be an event almost every night and some nights more than one event. It would be quite hard to move the date.

I think we understand it is a lot of material for people to absorb from Oct 7, but I think it is important to get the discussion going quicker after the resubmittal so we can have more robust discussion, even if it is clarification questions. So that all the various meetings that happen after the Oct 15 they have a better concept of the resubmittal.

Additionally, from resource standpoint, the longer between the presentation and meeting, means more questions potentially or groups rushing for answers before the community meeting. I think having the meeting earlier after the presentation allows us to address their question sooner and allows us to incorporate more of the follow up in any of the meetings after Oct 15.

From my experience, more time to see the materials does not equate necessarily to many more people reading it more in depth and more often people forget their questions. I think we rather get the discussion rolling while the resubmittal is fresh in people's mind.

Also, for information purpose, the DSAP Community meeting is tentatively scheduled for 10/29.
