Here's the response we can send to D3. This is the language we reviewed yesterday and will go live on the Diridon project website soon.

The City is currently focused on the emergency response to the coronavirus pandemic. The effect on the overall timelines for Diridon Station Area projects is unknown at this time, but the new target for City Council consideration of Google's Downtown West Mixed-use Plan and amendments to the DSAP will shift from end of 2020 into the first half of 2021. Outreach and engagement will continue using online methods while restrictions are in place and staff capacity is limited. When possible, the City intends to resume a similar engagement process but with shifted end dates. Additional information on revised timelines and public engagement approach will posted to the Diridon project website soon.
