PROCESS FOR DIRIDON STATION AREA AND PROPOSED

GOOGLE MIXED-USE DEVELOPMENT

Diridon Station Area Plan (DSAP) Amendment and Google's Downtown West Mixed-Use Plan

Google, Inc. (Google) submitted its application for a mixed-use development project (Downtown West Mixed-Use Plan) to the Planning Division on October 10, 2019. The project site is approximately 80 acres, largely within the Diridon Station Area Plan (DSAP) boundaries of 250 acres. The initial submittal focuses on the land use, transportation, and infrastructure framework; subsequent submittals will include additional details and information on design. The Google proposal includes a General Plan amendment (including amending the DSAP), Planned Development Rezoning and Planned Development Permit.

Since submission, staff has been reviewing the proposal for consistency with City policies and preparing an Environmental Impact Report to analyze the potential impacts of the project. The Memorandum of Understanding (MOU) approved by City Council on December 4, 2018 provides a foundation for this review process. As part of the entitlement process, the City and Google will negotiate a Development Agreement, which will include a Community Benefits Plan. The full application and associated information about the project is available at: www.sanjoseca.gov/GoogleProject.

Concurrent with reviewing Google's proposal, staff has initiated a process to amend the DSAP. The purpose is to adapt the Plan to current circumstances, align the DSAP with other adopted and ongoing plans, including the Diridon Integrated Station Concept Plan, as well as support DSAP implementation (private development and public investments). The guiding principles of the DSAP will remain the same; however, anticipated changes include adding development capacity and updating the sections on land use, design, transportation, and public spaces. addition, the City will prepare areawide studies or implementation plans on affordable housing, parking, and infrastructure financing. Consistent with City Council direction, the aim of the Affordable Housing Implementation Plan is to identify potential pathways for achieving 25% affordability among new housing in the Diridon Station Area.

The goal is for City Council to consider all of these items together in late 2020. Throughout this process, staff will continue to coordinate with the Diridon Integrated Station Concept Plan and other separate but related projects.

Community Engagement

As part of this work, staff is considering previous and ongoing community input, including those documented in the 2019 Diridon Station Area Civic Engagement Report (October 2018). The City plans to conduct four rounds of public outreach and community engagement over the next year, based on this <u>Draft Community Engagement Strategy</u>. Staff will continue to coordinate outreach and engagement efforts with separate but related projects such as the Diridon Integrated Station Concept Plan. The objectives of outreach this fall are to increase understanding of the planning and development review processes and get feedback on initial concepts under consideration – including Google's development proposal, the City-initiated DSAP amendment and the staff-recommended Concept Layout for Diridon Station.

As part of the first round of engagement, the City recently held a Diridon Station Area Community Meeting on November 18 at the Leininger Center and will host a similar meeting on **Saturday, December 7 at 10:00 am at the Gardner Community Center** (with a focus on reaching Spanish-speaking residents). Staff has also held three small group meetings of the Diridon Station Area Advisory Group (SAAG) on November 19, November 21 and December 2. The next regular meeting of the SAAG is scheduled for **January 16, 2020**. Attached to this memo and posted at www.diridonsj.org/resources are the handouts prepared for this round of outreach. The set of handouts describes all the interrelated planning projects underway.

In addition to these events covering all of the major Diridon Station Area projects, the City is hosting a public meeting specific to the Google project (Downtown West Mixed-Use Plan) on **Thursday, December 5, 5:30-7:30 at the Martin Luther King, Jr. Library, Room 225**. The purpose of this meeting is to inform the public about the proposed project, answer questions, and receive comments to help City staff and the applicant address any project issues early on – consistent with City Council Policy 6-30: Public Outreach.

In order to support implementation of the Community Engagement Strategy and achieve its objectives, the City is offering small grants to community-based organizations to assist with public outreach and community engagement. Specifically, the project team aims to expand the number and diversity of community members providing input on Diridon Station Area projects. The grant application period has been open since October 24. Applications are due December 9, 2019 at 11:59 PM.
