Shannon, David: I went back into the ceqasubmit.opr.ca.gov website and found that there was, in fact, a button to click to "Submit Document" that I had missed yesterday. So the DEIR now shows up as "Submitted" on CEQA Submit.. However, it is not yet on ceqanet.opr.ca.gov, so I imagine that OPR staff may have to take some affirmative step to do that. (The NOP and the AB 900 notice from last year both show up as "Published," rather than "Submitted," so I guess the DEIR will change to "Published" when OPR tells it to do so.) The CEQA Submit User Guide says that documents submitted by 3:30 p.m. will begin their review period that same day, so we are well before that for today.

Thanks, and I apologize for missing this yesterday. However, it doesn't appear that we will lose any time as a result.
