Shannon, David: Here is the first batch of the Hazardous Materials appendix files. ApxG0 contains the list of HazMat references, while ApxG1 through G28 contain the individual Phase I and Phase II site assessments and other documents. Many of the files are very large as they contain several individual documents. There were, however, several individual documents that were password protected (which I had not known) and therefore could not be combined; these individual files are much smaller. Note that each document in the ApxG0 list contains a notation to direct the reader to the applicable ApxG file where that document can be located. Please let us know if you are able to access the documents.
