Hello Downtown West Team,

As you know, we are marching forward this year on a very structured timeline to prepare Google/DSAP recommendations for consideration by Planning Commission in October, and City Council in November.

Attached is our game plan for the review of the 2nd Administrative Draft EIR for City Departments. The 2nd ADEIR will be in on **February 10** and we have to submit combined City comments to the environmental consultant (ESA) **by February 28**. This is a very quick turnaround and ***will require you plan for significant dedicated, uninterrupted time for review.***

We will have dedicated meetings on **February 19 – 21** with the environmental consultant and, if needed, the applicant, to ask clarifying questions prior to finalizing comments. Invites for these meetings will be sent out separately.

To aide us in this quick review period, please have each Department must nominate a team member to coordinate, collect, and enter Department comments from all team members in track changes in a Word document (to be provided). This team member will then submit the combined comments to Shannon Hill and David Keyon by **February 25** at the latest. Comments submitted after this date will not be incorporated into the City's combined comments.

After City comments are submitted, we will have several meetings with the environmental consultant for clarification. Some Departments (i.e. PRNS, DOT/DPW, and Housing) will be invited to attend a portion of this meeting to help the environmental consultant address the comments. Currently, this meeting is planned around **March 4** (may be spread over several days).

I also want to note that during the month of February, some of you will be involved helping prepare materials for the Spring Round #2 of community outreach, which kicks off with the SAAG meeting on March.
