Hello Downtown West Team,

Attached is our game plan for the review of the 2<sup>nd</sup> Administrative Draft EIR for City Departments. The 2<sup>nd</sup> ADEIR will be in on February 10 and we have to submit combined City comments to the environmental consultant (ESA) by February 28. This is a very quick turnaround and will require significant dedicated, uninterrupted time for review.
