RECOMMENDATION

Staff recommends that the Historic Landmarks Commission (HLC) review the plans for the Downtown West Mixed-Use Project (Google Project) under the "Early Referral" City Council Policy on the Preservation of Landmarks, 2006 (Attachment 1) to provide comments on the scope of the historic resources analysis to be included in the CEQA (California Environmental Quality Act) review, and the historic resources survey. See Attachment 2 for the Notice of Preparation for the Environmental Impact Report (EIR) on the Project.

BACKGROUND

The Project was filed with the City on October 10, 2019 and is a proposed mixed-use master development on approximately 80 acres within the Diridon Station Area Plan. Information about the Project can be found at https://www.sanjoseca.gov/googleproject. See Attachment 3 for a copy of the draft project plan set. The draft plan is focused on the project wide areas such as land use, open space, and transportation and as the project evolves additional details and exhibits would be incorporated.

The purpose of Early Referral is to give the HLC the opportunity to provide input and comments to staff and applicants on a proposed project's relationship with historic resources, to better inform project planning, facilitate the environmental review process, and help make findings pursuant to the General Plan policies for historic preservation.

The Commission's review covers historic resources and their treatment and includes designated City Landmarks and City Landmark Districts, resources listed on or eligible for the Historic Resources Inventory (HRI), and potential historic properties within and surrounding the Project Area.

A historic resources survey is underway covering all properties and features over 45 years old within the study area including the 80-acre project area and the surrounding properties within 200 feet. The survey work will help establish historic significance and eligibility. At this time, the survey is in the initial stages, but some information about the historic context and property types remaining is known. Attachment 4 is a summary memorandum on the initial survey phase done by the consulting firm Architectural Resources Group (ARG), documenting which properties in are project area are over 45 years old and which have been surveyed in the past.

The area was the industrial heart of the City with a good network of road and rail transportation for manufacturing and distribution. The historic mix of industrial, commercial, and residential uses remain in part for which some property types remain from those periods.

There are two designated City Landmarks within the Survey Area. They include the San Jose Water Works (HL91-57) which is located in the project boundary, and the Southern Pacific Depot/Diridon Station (HL94-100) within the 200-feet of the project boundary and is also on the National Register of Historic Places.

There are no designated City Landmark Districts or Conservation Areas within the project area, but a portion of the Lakehouse City Landmarks District (HD07-158) is within the 200-feet of the project boundary. There are also several properties listed on the HRI, added at various times under various surveys from the past. Updates for all HRI properties is currently being done as well as surveys for properties not on the HRI, but over 45 years old.

EVALUATION AND FOLLOW-UP

The completed historic resource assessment identifying and classifying the significance and eligibility of historic resources at the local, State, and National levels will be included in the Project CEQA document. The document will also discuss any impacts to resources identified. The HLC will have the opportunity to review the CEQA draft EIR document during the public review and comment period.

Any work to the exterior of the Water Works (HL91-57) and Southern Pacific Depot/Diridon Station (HL94-100) may require an HP permit, and depending on the scope of the work, may require a formal review and recommendation of the HLC before approval by the Planning Director.
