Mr. Smialek: I have forwarded your contact information to Shannon Hill of the San José Department of Planning, Building, and Code Enforcement, who is working on the environmental impact report for the Downtown West Mixed-Use Plan in San José. This is a proposal by Google to construct a large mixed-use (office, residential, retail, and other uses) project in the vicinity of Diridon Station, which is served by Caltrain, Altamont Corridor Express, and Amtrak Capitol Corridor trains. The tracks through Diridon Station are also used by a small number of Union Pacific Railroad trains, and UPRR

owns a segment of track that runs through the project site and another that runs along the site's northern border; both of these connect to UPRR's Milpitas yard.

Where the UPRR tracks pass through the project site, there is only a single at-grade street crossing. The project applicant will likely have to undertake some sort of improvements to allow for adequate emergency vehicle access. This aspect of the project is described in the EIR project description (excerpt attached), which states that FRA approval may be required, depending on what is ultimately proposed. I also attach a map from the EIR showing the project site location (I have labeled the UPRR tracks).
