Hi Karl,

No, there is not an attachment, only the explanation. The first email from Cary in the thread was the Airport's comments on the DSAP Amendment Initial Study/Addendum. I have removed it from the thread, as it is not applicable to the DTW project and should not have been included. Cary mistakenly referred to the proposed IS/Addendum as an EIR.

Cary provided the explanation of the proposed Downtown Crane Policy timing in response to my follow-up question, and the information has been sent to Circlepoint for consideration in the DSAP Amendment environmental clearance as well. The key is "temporary construction cranes in the DSAP area are subject to FAA airspace safety review pursuant to federal regulations, and are required to obtain FAA 'determination of no hazard' clearances, just as proposed buildings are (depending on specific heights/locations)." This is mentioned in the analysis for **Impact HA-4** in the Hazards section, but the proposed Downtown Crane Policy is not included in the regulatory setting.

Hi Shannon,

There is no Downtown Crane Policy in place today. A proposed policy is in preparation (as directed by Council in March 2019), and the details have not yet been formulated. When drafted, Council consideration and approval of a proposed policy would not occur until at least early 2021.

Note that temporary construction cranes in the DSAP area are subject to FAA airspace safety review pursuant to federal regulations, and are required to obtain FAA "determination of no hazard" clearances, just as proposed buildings are (depending on specific heights/locations), so is already addressed in the EIR.

Does this take care of the question?
