Here is the draft SAAG ppt for your review and input, by COB tomorrow (Tuesday).

It is too long but we can use the extra slides for the Study Session ppt or reactive talking points.

Please recommend what we should cut and let me know if the slideshow is missing any critical info.

In general, **most slides still need talking points**. While we have until next Monday to finalize these, we need to make sure that we are staying within our time boxes which affects preparation of the draft slides to post this Thursday.

I tried to highlight the **missing info needed for the slides or points to confirm**:

- DTW Parking – verify recommended bullet points to simplify

- DTW Parks – verify level of detail
- DTW “Other Transportation Improvements” following TMD description
- DTW riparian corridor
- DTW Significant Impacts (historic resources)
- DA Interim Insights
- Next Steps on the Development Agreement
- Downtown West Feedback – verify prompts that apply to all three sections to tee up discussion
- DSAP infrastructure slide
- DSA Incentive Zoning
- Housing – verify final language on goals and strategies, add new performance measures, highlight changes made in response to feedback (if applicable) – text on slides now pulled from Sept 16
- Small Business – Approach slide: I recommend pulling these small biz slides into own powerpoint and putting online with a feedback form (using the prompts at the end of the section) – let me know if you have any questions or concerns with this
- Small Business data tables – Bige to provide updated tables
- For Kim, Nanci, and Vic to verify the framing and text:
 - Potential for Direct Displacement
 - Small Business Opportunities (private development and City role)
 - Feedback
