Thank you very much. The new Appendix X contains only Queuing and Blocking Reports, which are very useful regarding queuing at intersections.

I expected to see intersection level of service calculations - for all scenarios - as well, as referenced in Section 8.2. Furthermore, understanding the Synchro/SimTraffic analysis and findings also requires a clear understanding of the <u>network</u> of intersections and streets. It seems to me that diagrams of the respective networks should be available to clearly depict these critical elements, which drive the analysis and results.

Hi Shannon:

I'm reviewing the transportation sections of the subject DEIR for Sharks Sports and Entertainment. I noticed that *Appendix J2 Draft Local Transportation Analysis (LTA) Report* **does not contain** referenced appendix data for the SimTraffic analysis discussed in Section 8 Localized Access and Queuing Analysis.

Specifically, on page 186 there is a reference to Appendix B, which is supposed to contain calculation sheets. Appendix B in the document contains Approved Developments, so the reference here is apparently incorrect.

I note there are hundreds of LOS calculation sheets from <u>Traffix software</u> in the document behind Appendix B (there is no title sheet separating the information).

Bottom line is the SimTraffic analysis cannot be properly reviewed at this time, given there are no details included in the document.

Will you please look into this matter and let me know what you find?
