Nour – here is rundown on the housing goals issue in San Jose:

The City is working hard to meet its RHNA goals for market-rate housing and approve 10,000 new affordable apartments by 2022. Since that goal was established, more than 3,000 affordable apartments have been added to the City's development pipeline, including approximately 1,000 that are either completed or permitted. Ultimately, the City must find a way to fill a funding gap of roughly \$500 million to build the remaining affordable housing units. That will require better alignment between the State's RHNA requirements and its funding processes, or the creation of a new revenue source.
