Looking at the graphic provided in the DSAP, I would assume the riparian corridor as well as some of the rail corridor and some of the developable land west of the rail lines were all part of the community park that was identified.



Also, Lori was doing some digging and may have discovered some interesting context. The final land use map for the 2014 DSAP document only highlights the fire training site but previous draft maps show something more consistent with the image above. We are speculating that at some point, it was decided that the park site should just be on the fire station site and the text was never updated? Not sure about the truth behind this

speculation, but it does help explain somethings.
