- ADEIR-2--For the March 4th roundtable, which we are happy to hold in our office (depending on the size of the group), do you know who from the City would attend?

We should have a better idea of who from the City will need to attend once everyone has had a chance to review the EIR, so we know what the main areas of concern are, but it will be at least David and I. In addition, we may need a representative from PW, DOT, and ESD and Juliet Arroyo, the City HPO.

- AB 900 Admin Record--We would like to move forward with identifying schedule times for the Training, Make up Training, and the Pre-Publication Final Meeting/reminder; could you please let me know who is the appropriate person for us to coordinate with on this? Also, we are hoping to see the Task Order early this week so we can start on compiling training materials, do you think that's possible?

David has been coordinating this effort. However, you can include both him and I on coordination efforts. I have not been involved in Task Order execution, but I can follow up with Page tomorrow when he is back in the office.
