No, we have not discussed that, but compliance with the SCVHCP does not come into play until the entitlement phase, and the Biological Resources section of the EIR includes a discussion of likely requirements to comply with the HCP when the time comes.

Regarding relationship to the Muni code, I would need clarification on what they are asking. I don't believe there is any relationship to the code, but GP policies speak to the requirement to comply.
