Thanks for sharing this document. Here are a few suggestions for specific pages:

Pg. 2.41, Primary Public Plaza & Pg. 3.35 Diridon Plaza

- Add accessible loading areas to facilitate equipment drop off and pick up for temporary setups on the plazas.
- Add strategically placed electrical vault locations.
- Create specific areas within the plaza space that may allow for more load bearing structures or define the maximum load capacities for each plaza.
- Design plazas with attractive and durable surfaces (e.g. no soft stones which crack easily).
- Install light fixtures on a grid that will not obstruct the concept of an open plaza.

Pg.2-43, Green Street

- Any street intended to be transformed as an extension of a plaza and/or closed to traffic on a temporary basis should be designed to allow for attractive barrier placement. Barriers should meet
 - MUTCD standards.
- Streets intended for event use should be designed with standards that easily transfer to event space with the deployment of non-standardized crosswalk designs, lighting, street signage (similar to Santana Row).
