Thanks for chatting with me about this earlier. In following up to our conversation, please response to the following items:

1. Please provide GIS files showing the boundaries of the following parks: 1) Guadalupe River Park, 2) Arena Green, and 3) McEnery Park. ESA needs specific boundaries for the shade/shadow analysis. If the GIS files your contact would provide are the same as what is available online, please confirm, and I'll let ESA know.
2. Based on our conversation, it's my understanding that Arena Green will be considered as part of Guadalupe River Park PRNS's review of the DEIR, even though they are technically separate, but please confirm as this will affect the outcome of the analysis.
3. Related to the previous request, if Arena Green will be considered separately, please provide a description of why it is not part of the Guadalupe River Park, so the description can be included in the setting information of the DEIR.

This request is highly time-sensitive because the analysis needs to be include in the DEIR due to be submitted on 2/10, so please respond ASAP.
