Kevin,

We think it makes sense to review what Google has sent and, assuming we get it by tomorrow morning, to discuss with them the implications of that information on what should be included in the City's interconnection application/SIS agreement. Note that on further reflection we are thinking that it may not make sense to adjust the load forecast to accommodate the construction power loads after completion of the substation. Excluding them shouldn't change the overall SIS results, avoids giving PG&E another thing to complain about, and shouldn't preclude the City deciding at a later date to serve those loads. We should also discuss how we might be able to use/modify Google's materials for use in the City's application (for example plot plans, diagrams) to minimize differences. Also, it would be good to get any feedback/information they have received from PG&E on their application/SIS.
