Thank you for this morning's call and for the summary/action items. I took the liberty of revising Items 3 and 4 to more clearly capture those points:

- 1. Flynn has staff assigned and working on Task 1. No issues or concerns at this point.
- 2. Flynn is requesting additional information related to the infrastructure that will be needed as part of task #3 and if/when CSJ progresses with a service application. We agreed that having a meeting with city staff most familiar with the DSA plans, possibly in the field, is needed. Next week, Flynn will provide specific descriptions of the information needed and some dates and times that they are available for a meeting prior to 12/16. Kevin will identify city staff to be involved and arrange meeting.
- 3. We discussed that the City is transportation agencies are considering the relocation of Station A for future rail alignment, but responsibility for associated costs would be a requirement of that project and don't need to be considered as part of this effort
- 4. We discussed that possible deficiencies in the 115 KV system serving the line from San Jose/Santa Clara area could impact future service applications and therefore timing of any application is important to reduce the chance of being the party triggering upgrades.
