Thanks for being willing to pursue the funding renewal. Believe it or not, I would say that Zac spends at least 70 percent of his time on Google and/or Diridon. If I recall, I believe that we requested 80% funding from Google.

Yes—I plan to start discussing our budget needs for FY 20-21 with Google tomorrow afternoon, but fully expect we will have another Service Reimbursement Agreement for FY 20-21.

It would be helpful to have a few sentences from you describing what the position will be doing in the FY 20-21 time period (in the next few days is fine).

(Also—my impression was that Zak's work hasn't exactly been full-time on Google/Diridon this fiscal year, but correct me if I'm wrong. That's OK, I just want to be upfront about that if asked.)

On a related note, my awesome Diridon Community Engagement Manager/Program Manager Lori Severino will be going on maternity leave from about mid-April to end of July—a key time for all of our Phase II Diridon efforts to start coming together into the recommendation package. I need to develop a plan to cover Lori's two roles while she is out, and we think Zak would be the best person to manage the Community Engagement component. He is quite involved on her inter-departmental community engagement team already and seems interested and very capable in this community engagement work.
