- San José can take wholesale transmission and/or distribution service to serve customers within the City (under the PG&E FERC TO Tariff or Wholesale Distribution Tariff and CAISO Tariff), most likely at a transmission level point of interconnection within the DSA for the Google Project.
- □ San José can revoke all or part of PG&E franchise in the city, and provide power services itself, or create a new franchise with another entity to do the same.
- E20T retail service to the Google Project is not consistent with current PG&E CPUC-approved Electric Rules requiring PG&E ownership of facilities within public rights of way and requiring separate PG&E metering for each building and individual tenants
- There is uncertainty about implementation of microgrid service standards mandated by SB 1339, required impact studies, rates and tariffs, and the outcome of a working group to codify standards and protocols needed to meet California electrical corporation and Independent System Operator microgrid requirements.
