I might look at is another way:

Google dedicates some land. The dedicated land + Google land is put under operating contract to the conservancy. The conservancy can operate the lands in whatever way they see fit, including hiring private security.

If the operating scenario that Google is trying to develop consists of the city operating the city owned parks and them not being included in the conservancy then I would expect them to operate like a neighborhood park, with no Ranger support. They would be periodically patrolled by PD with security provided for special events. The challenge is that we only have about 11 rangers for the whole city so it's not possible for them to staff neighborhood parks.

One suggestion is that you might want to schedule time for a more detailed discussion with Torie about this. I'm concerned that the one-off emails are a little out of context so it may be hard to make sure you are getting the right info. Just my thought...

  - The staffing model assumed a high level of care. Parks staff
    were asked to provide estimates based on public spaces that
    would be activated heavily (5 days a week), in a style similar to
    activation of Plaza de Cesar Chavez.
- Are the O & M staffing requirements shown, dedicated staff?
  - These would be dedicated staff. The staffing model suggested is similar to staffing models we have for our park districts around the city. Essentially, the level of care projected and associated staffing model provided would be akin to our Department creating am entirely new park district.
- Is trash and janitorial included in the costs shown?
  - Yes, this is included in the maintenance model we would employ.
