The competition to solicit concepts for a unique and iconic structure in Arena Green has closed. Through the process, submissions have been narrowed down to three primary finalists. This item is an informational update only, no action by the Parks and Recreation Commission is required.

Overview of Downtown West Project and Design Standards and Guidelines

The Downtown West project, more commonly known as the Google project, is expected to release the project's environmental impact report and design standards and guidelines in August. This item will provide a brief general overview of the projects open space plan. The presentation will focus on the review of the Design Standards and Guideline (DWDSG). The DWDSG are intended to be the governing rules for the design and development of the projects future open spaces, both private and public. Commissioners will be asked to provide a recommendation to Council for the approval and adoption of the design guidelines for the Downtown West project.
