Council Policy: Naming of City-owned Land and Facilities 7-5

Background

- Purpose
 - Establish council policy regarding the determination of names to be given to Cityowned land and facilities that are not streets.
 - Council Policy 6-5 address streets.
- Agency Responsibility
 - City Council and City Staff are responsible for the naming of city facilities.
 - Policy does not explicitly state outreach requirements.
 - Best practices encourage public participation in soliciting names from the community.
- Objectives
 - Names that reflect the City's ethnic and cultural diversity.
 - Recognition of distinct geographic, environmental or developmental features or names of historical significance in naming city lands and facilities
 - Recognition of individuals who made a significant contribution to San Jose, the State, the Nation, or the World.
 - Naming as early in the capital planning and development process as possible.
 - Sponsorship
 - See policy for details on sponsorship requirements.
- Policy and Naming Requirements
 - Public hearing by appropriate Commission to develop recommendation.
 - Reflective of at least one criteria:
 - Geographic location
 - Prominent geographic feature or local reference point
 - Adjoining subdivision/community
 - Historical event
 - Deceased individual (5+ years)
 - Individual or group via donation or sponsorship agreement
- What works, what doesn't?
 - Clear, prescriptive requirements.
 - Unclear engagement guidelines.
- Update goals
 - Modernize engagement process.
 - Streamlining process.
 - Increasing participation.
 - Identifying more/better names.

Survey Process

- Pre-survey
 - Preparing/updating outreach materials.
 - Preparing outreach messaging.
 - · Translation of materials.
- Survey Period
 - Two surveys, one to solicit names, one to vote on names recommended.
 - Standard timeline for whole survey process is 4-6 weeks.
 - Includes:
 - Approx. 1-2 weeks to develop surveys, outreach flyers, stakeholder list, messaging.
 - One week for solicitation survey.
 - One week to review and consolidate names.
 - One week for voting survey.
 - Option if survey has low level of engagement.
 - Secondary notification blast.
 - Extension of surveys.
- Post Survey Period
 - Approximately 12-14 weeks
 - Depending on when the memo drafting begins.
 - Will discuss in post survey slides

Survey 1 - Solicitation

- Develop working title.
 - Use closest cross street or adjacent street.
 - IMPORTANT: clearly communicate nature of working title to those involved in the process (PBCE/PW) to avoid ordering incorrect signage.
- Stakeholders and outreach avenues look to engage as may outlets as possible.
 - Community meetings regarding park development
 - Neighborhood groups
 - Adjacent schools
 - Park advocates
 - Council district office
 - Youth and Senior Commissions
 - PRNS social media
 - Facebook
 - Nextdoor
- Solicitation Voting
 - Nomination vs Solicitation
 - Anyone can nominate by completing the required nomination form.
 - All nominated names must be presented to the Parks and Recreation Commission for consideration.
 - Requires all sections of the forms to be completed.
 - Survey acts as an open call for names and justification.
 - Ensure survey includes language that:
 - Indicates that staff will review all suggestions.
 - Participants can nominate their own by completing the form available online and submitting it to staff separately.
 - Advertised through stakeholder and outreach avenues.
 - Suggested survey duration is one week.
 - Most responses will be in the first two days of posting.
 - If response rate is low, a second social media blast is recommended 3-4 days after initial post.

Survey 2 - Voting

- Pre-second survey
 - Staff review of submitted names for policy conformance and appropriateness.
 - Prepare survey with names being put forth for voting.
- Voting
 - Second phase is intended to allow residents to choose a name from those solicited.
 - All conforming names and justifications are presented for voting.
 - Advertised through stakeholder and outreach avenues.
 - Name which receives the most votes is to be presented to PRC to review for council adoption.

Post Survey Process

- City Nomination Form
 - Deeper dive research on highest voted name.
 - Ensure suggested name meets policy requirements.
 - Identify any additional support for proposed names.
 - Complete the city nomination form.
 - · Send form to clerk office.
 - Which is then forwarded to the appropriate commission to schedule public hearing.
 - Request any additional nomination forms from the clerk's office.
- Parks and Recreation Commission
 - Identify target PRC date.
 - Develop PRC memo/presentation.
 - Be sure to include original justification provided, as well as any additional support identified.
 - Memo routing:
 - Follow standard PRNS memo routing procedure.
 - Inform submitter (if possible, participants can voluntarily include contact information) of the PRC time and date. Let them know they can speak on behalf of their suggestion if desired.
 - Draft letter from PRC to CLERKS OFFICE identifying recommended name and requested council hearing date to be agendized.
- Council Hearing
 - · Identify target Council date.
 - NOTE: PRC must meet to recommend the name prior to the 6-week internal memo routing period.
 - Develop Council memo/presentation.
 - Memo routing
 - Follow standard PRNS memo routing procedure.
 - Best practice is to draft PRC and Council memos together if possible.
 - That way, the council memo should only need to update with the PRC discussion and vote.

Renaming and Naming Facility Amenities

- Renaming of facilities:
 - Preference is for the retention of long standing names.
 - Criteria:
 - Substantial contribution to the City facility in accordance with Policy 1-17.
 - Reasonable efforts to incorporate existing names (i.e. Dr. Roberto Cruz, Alum Rock Library)
- Naming of amenities:
 - Is not required to follow policy.
 - Requires CMO approval.
 - Guidelines are part of department internal fundraising and sponsorship guidelines as referenced in City policy 1-17.
