Thanks, Shannon. I added some of Zak's language so that we have now included the following, which I believe is consistent with what Zak is saying:

The NOP project proposed approximately 16.8 acres of open space, while the project analyzed in this EIR proposes about 15 acres of open space. The reduction is due to elimination of one open space area that would have been located on the Caltrain parcels and to refinement of open space typologies (i.e. semi-public vs. riparian vs. open space, etc.), as well as minor adjustments to block boundaries and private streets, as compared to the plan contemplated at the time of the NOP.
