It's hard to imagine that less than three years ago there was a campaign by a group to thin or cut down all the trees. It is also quite distressing to know there are some who are still proposing projects that will eliminate the trees. Arena Green West and all of its trees were part of a court settlement about riparian mitigation back in 1993, so it is particularly surprising that the proposals are being entertained. I guess we'll have to see how that plays out.
