Per our conversations with the DANG (Diridon Area Neighborhood Group), I'm confirming our first working group meeting with planning on Thursday, August 27th at 7 p.m. via Zoom. Our office has offered to coordinate these meetings similar to our working group with the Bascom Warming Center last winter. I've also copied Councilmember Peralez and Christina Ramos since some of the residents of this group live in D3 and their office may want to participate.
