- We are holding a regular meeting of the Station Area Advisory Group (SAAG) tomorrow evening (Jan 16) at 6:00 PM in the City Hall Wing Rooms (118-120). The meeting will include three staff updates on: Community Engagement, the Google project (processes for developing the Development Agreement and conducting design review), and the Diridon Integrated Station Concept Plan. Each item will be followed by Q&A with the SAAG, with a public comment opportunity at the end of the meeting. The purpose of early referrals is to give the HLC the opportunity to provide feedback to staff and applicants related to historic resources to better inform project planning, facilitate the environmental review process, and make findings pursuant to General Plan policies. - On December 30, 2019, Governor Newsom certified the Downtown West Mixed-Use Plan
 (Google project) as an Environmental Leadership Development Project under the State's AB
