**Anticipated Timeline and Major Milestones:**

1. October 10: Google submits an application to the City to start the formal development review process
  - a. CALL OUT BOX: The first submittal includes the following components:
    - i. Project Description and The Proposed Development Program
    - ii. Existing Context
    - iii. Proposed General Plan Land Use Designations, Zoning Districts, And Land Uses
    - iv. Proposed Maximum Building Heights
    - v. Conceptual Transportation and Open Space Networks
    - vi. Conceptual Infrastructure Plan
2. October 24: Noticing for EIR Scoping Meeting and other engagement

opportunities

3. November 7: Google Project EIR Scoping Meeting
4. November 9: Staff deadline to provide an Application Completeness Letter to Google
5. Fall 2019/Winter 2020: Google submits subsequent information, including detailed development standards and design guidelines
6. March: The City releases the Draft EIR for public review
7. Spring: City Council Study Session
8. Summer: The City releases the Final EIR for public review
9. Fall: Noticing sent out on public hearings to consider project approval
10. Fall: Planning Commission hearing\*
11. Fall: City Council hearing\*

\*Staff report posted 10 days in advance of meetings

Note: This tentative timeline does not include all of the anticipated engagement activities that the City will conduct for the Google project and other plans affecting the Diridon Station Area.
