- 1. Application is somewhat unique because of size
 - a. First submittal will not include as much detail as typical development project applications but more detail will follow
 - i. Presumptuous to know building design (how it will look) at this stage still working on the framework
 - ii. We are addressing the big topics first: land use layout, maximum building heights, circulation, infrastructure, etc.
 - iii. Analyzing the overall context of the large project site and DSA
 - iv. This will lead to more details on building design, which will be context specific
 - v. Community engagement will help inform the rules
 - b. Google plans to submit the next set of information to PBCE in early 2020, with outreach following in early spring (Round 2)
 - i. This will include detailed building and landscape design
 - ii. The PD Zoning will establish the rules for the project site
 - These development/design standards will have more detail than typical PD Zonings

- 3. These rules are very important because they will dictate future development
- 4. This require more outreach and analysis at this stage comprehensive planning process
- 5. Legislative action (City Council action)
- iii. PD Permit: entitlement that allows you to go to building permits makes the zoning effective
- c. If Council approves the project (all associated actions), then Google or its development partners would submit application for building permits
 - i. Staff will review the application for consistency with the detailed PD Zoning rules
 - ii. Buildings will not go to Planning Commission
 - iii. This gives more certainty to Google adds value that is reflected in the DA + Community Benefits Plan

- This is kind of like Santana Row with respect to phasing: conceptual to more detailed
- ii. Process done before in San Francisco with large projects like Pier 70
- e. Google: We are doing what we said we are going to do going to continue to engage around key pieces
