I've mentioned these findings verbally but want to provide this written summary of the Small Business Cafecito that LatinX Business Circle and SOMOS hosted in October. I'm expecting a more formal summary soon.

Questions about Downtown West and DSAP:

- How can we take advantage of these plans?
- How much space will be reserved for small businesses?
- How can one rent a space and how much will it be?
- Will there be financial aid?
- What other kind of support will there be?
- How will the City help protect small businesses from displacement?
- What are the requirements? How can we get jobs in the new area?
- Timing? When will construction occur? When will new spaces be available?
- Have you already communicated with the businesses that are going to be impacted by this project?
- When are there going to be more cafecitos for other businesses to participate?

Concerns:

- 1. Cost to locate in new spaces
- 2. How small business can get/stay involved
- 3. "We pay annually for union licenses to be able to do this work, but others without licenses are coming in and taking our work away." Hire local!

Key takeaways:

- It's important to take us low-income businesses into consideration for projects like this. This means involving us in the process, ongoing communication about opportunities and impacts, and listening to our feedback and needs.
- Be clear about how small businesses can take advantage of contracting opportunities (e.g., catering, food trucks, construction, etc.) especially for small, local, and immigrant-owned businesses.
- Business owners are interested in financial support and other protections to locate and stay in the DSA.
