Councilmember Peralez,

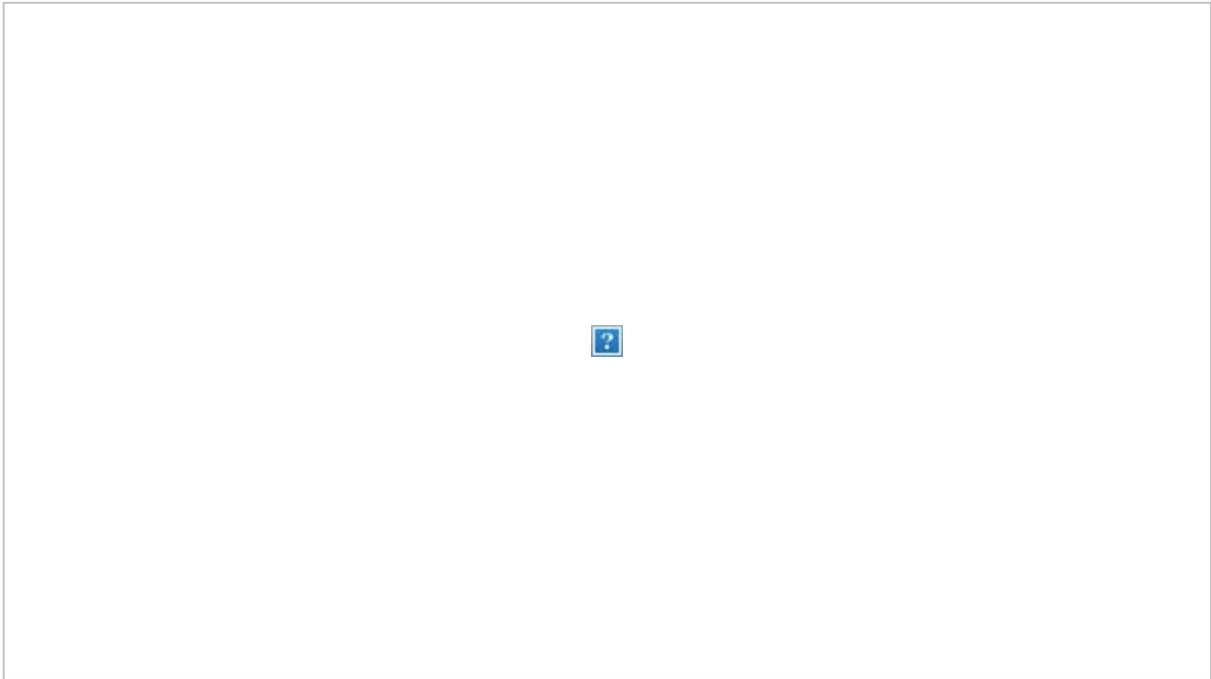
