Hello Community Members,

This fall and particularly during December, you have the chance to shape one of the most extraordinary planning efforts happening in any U.S. city. We are in an important phase of project and plan review and community engagement for the Diridon Station Area.

Several draft documents have been released this fall for Google's **Downtown West Mixed-Use Development Project** and the **Diridon Station Area Plan (DSAP)**. Concurrent with reviewing Google's 80-acre development proposal, City staff initiated a process to amend the DSAP, adopted by City Council in 2014. Staff have also released the draft Diridon Affordable Housing Implementation Plan that addresses City Council's direction to achieve 25% affordability of all housing built in the Diridon Station Area.
