By the way, on the topic of visual impairments, when preparing documents for public review please note that font colors are easiest to read when there is the greatest contrast. For example, black on white is easiest, and dark red on white is also pretty good. Orange/yellow/green font is extremely difficult to read, and grey/blue/purple can also be very difficult depending on how dark/bold the font is.

I'm not suggesting that documents already prepared need to be revised (such as the DSAP amendments), but it would be great if you could keep this in mind for future documents. Your understanding is greatly appreciated.
