An update on the question of the Downtown West phasing plan.

Florin (cc'd) is going to send you the phasing diagram and info in the draft and final EIR, which are

our current best estimates of how the DTW project will be built out.

That said, there is intentional flexibility about this phasing and how the DTW project will actually be built out over time.

We understand that the BART project team has reached out to Google about this as well to discuss. That's great. We think that a single multi-party (VTA, City, Google) discussion of this would be the best way to get clarity about proposed plans and our best process(es) moving forward to stay coordinated.

We're hoping that this can happen on Friday afternoon (I heard Florin mention perhaps 4-5pm, which works for me) – but I'll let Stacey / Dennis finalize that timing and "make it so" on our calendars.
