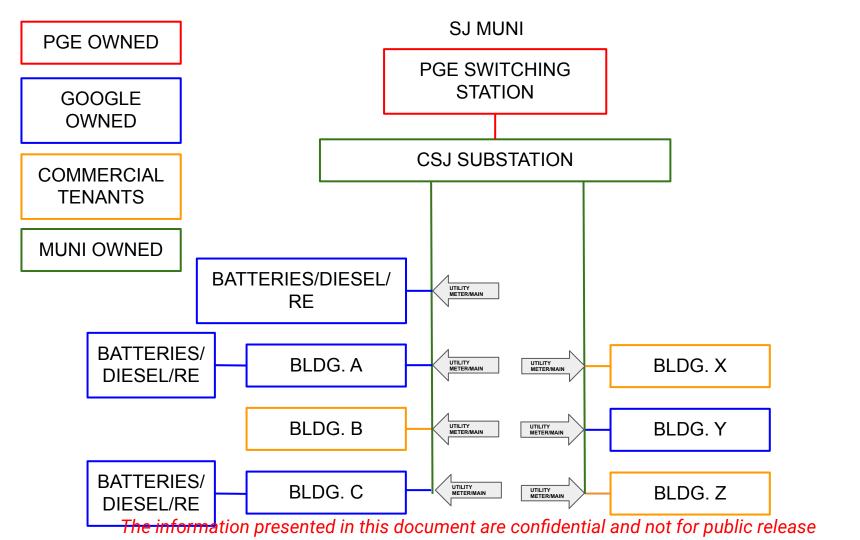

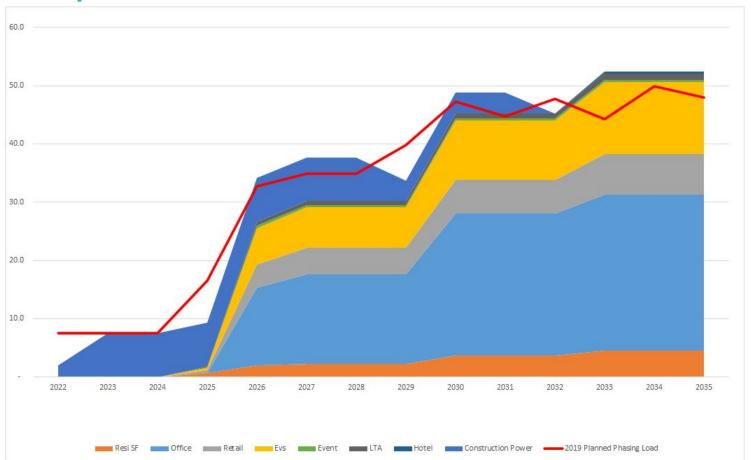

Load Updates

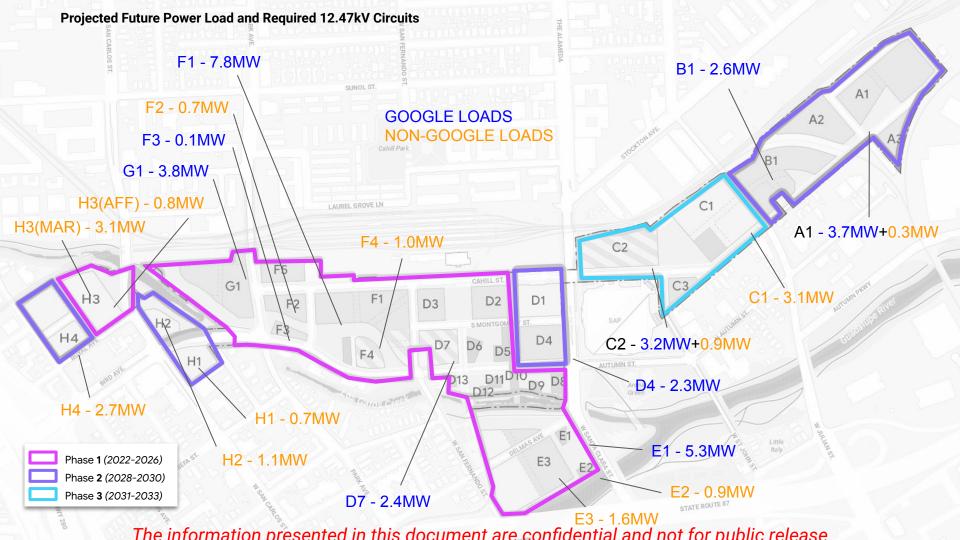
- EV loads have been increased due to the inclusion of Bay Area REACH code agreements. Accounting for 100% parking spot coverage for service load calculations with L1, L2, and L3 (DC Fast Charge) capability distributed throughout the site as required. Represents a code required minimum load on distribution system.
- Thermal loads at CUP have increased due to 8760-modeling refinements and updates to programing. Net GSF reduction for total site program being offset by net GSF increase for Office use type, which has higher CUP load requirements than other use types.

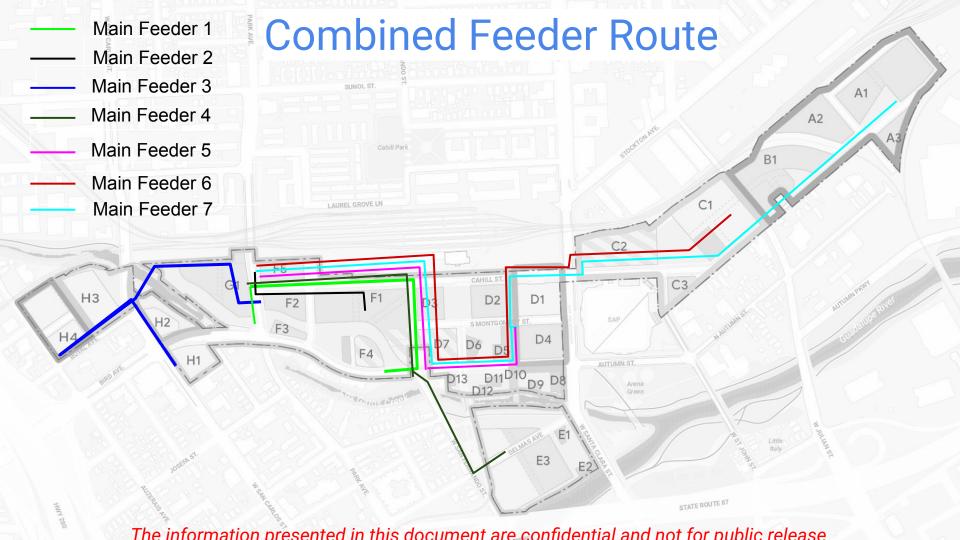
