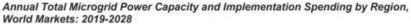

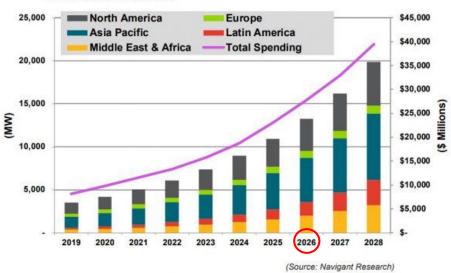

# Microgrid - Evolution and Growth of Established Market





Microgrids adoption is accelerating, with a doubling of the market up to **2026**.

Growth underpinned by maturing regulatory, technology & market mechanisms.

The US will remain the top market for grid tied microgrids.

Significant market consolidation, a sign of a maturing market is occurring, with large corporations acquiring small innovators, and technology providers to offer turnkey solutions.

- In a separate study by GTM Research, Microgrid capacity in the US is forecasted to double from 3.2 GW in 2017 to 6.5 GW in 2022 (at a compound annual growth rate of 14.1%). Downtown West is anticipated to be 40 MW, or 1% of global microgrid capacity in 2019.
- Globally, microgrids are anticipated to grow at 19% per year between 2020 to 2025
- Federal/State funding has increased exponentially. Over 5-years from 2012, US states committed \$86M to microgrid technology innovation and \$189M to microgrid construction. In 2020, California approved a \$200M budget incentive program for complex multi-property microgrids.

The NREL's 2018 <u>microgrid cost study</u> outlined the location and sectoral breakdown of Microgrids in the US.

The scale and penetration of commercial microgrids is growing.

Advances in the institutional sector, both in terms of deployment and research is reducing cost and improving technology and controls.

In response to aging grid infrastructure and extreme weather events leading to increased frequency of power outages, growing numbers of US states have approved microgrid support programs.

**112 bills** have been proposed or enacted in 18 different states over the past 5 years - addressing Microgrids

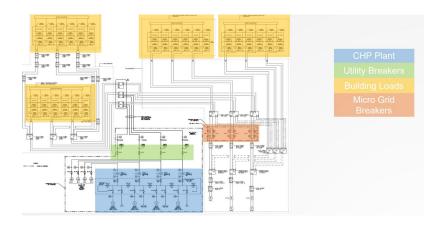

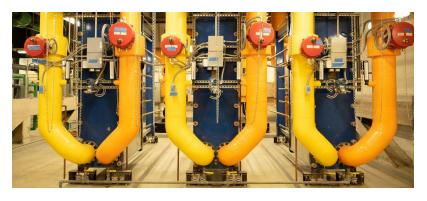

# **Hudson Yards District Systems - Development Overview**

<u>Hudson Yards</u> is the largest private real estate development in the history of the United States and the largest development in New York City since Rockefeller Center.

The site will include more than 18 million square feet of commercial and residential space, more than 100 shops, a collection of restaurants, approximately 4,000 residences,

The Shed arts center, 14 acres of public open space, a 750-seat public school and a Hotel with more than 200 rooms.

District Systems are an integral part of Hudson Yards story, with a first of its kind microgrid and two cogeneration plants saving 24,000 MT of CO2e greenhouse gases from being emitted annually by generating electricity.

A centralized hot and chilled water for the neighborhood with over twice the efficiency of conventional sources.

Organic waste collection systems and storm water collection.

District Systems Operational Structure - Highlights
The systems are owned and operated by the Hudson Yards
Microgrid Company (HYMCo).

HYMCo operates the systems to deliver environmental & economic performance while increasing resilience - in response to concerns on flooding/extreme weather (Hurricane Sandy).

There is a private operating model which controls the relationship between the commercial owners, condos and HYMco.

The contracts have prescribed provisions to enable future assignment. New operators/successors will be qualified in the management of the systems including CHP systems.

There are provisions to address the failure of the business or service (microgrid and thermal), with a range of remedies, including temp solutions & self help.

# Microgrid Policy Trends

Federal policies in recent years have acted as a catalyst while supporting state action and policies. Example below;

• FERC Order 2222 allows behind the meter batteries, PV, and demand response to compete in the energy, power, and ancillary services wholesale power markets, providing increased potential value for behind the meter microgrids. This followed on FERC Order 841 which allowed fair, equitable market access for energy storage.

In recent years, the state has released numerous policies in support of microgrids.

- In 2018, SB 1339 was passed which directed the CPUC, CAISO and CEC to develop a microgrid policy framework
- In 2019, the CPUC issued rulemaking R.19-09-009 to establish a proceeding for developing a microgrid policy framework with 3 tracks track 1 (focused short-term improvements), track 2 (State's broader policy goals) and track 3 (long-term implementation of SB 1339)
- As of 2019, the CEC provided a total of \$84.5 million in funds to build 20 new microgrids across California under the EPIC program
- In 2020, the CPUC approved PG&E's Community Microgrid Enablement Program (CMEP), through which PG&E will partner with local communities to identify and build multi-customer microgrids.
- The CEC's Electric Program Investment Charge (EPIC) Program has funded demonstration single-customer microgrids and grid-interactive storage to advance the development, deployment, and market maturity of microgrid technologies.

In the last month (January 14th, 2021), the CPUC adopted 6 new strategies to facilitate commercialization of microgrids statewide;

- A revision of IOU rules to facilitate microgrid deployment
- Adoption of IOU renewable microgrid tariffs
- Approval of a \$200M microgrid incentive program aimed at supporting vulnerable communities impacted by grid outages and to test new technologies or regulatory approaches

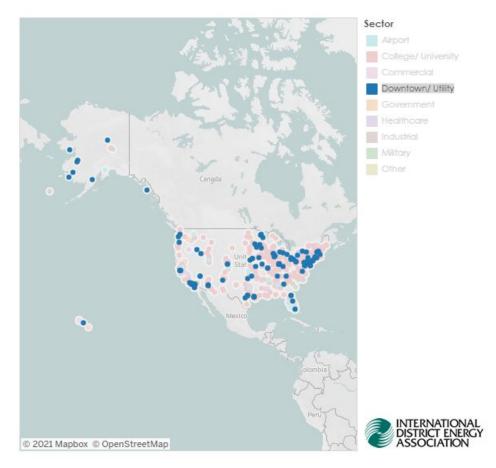

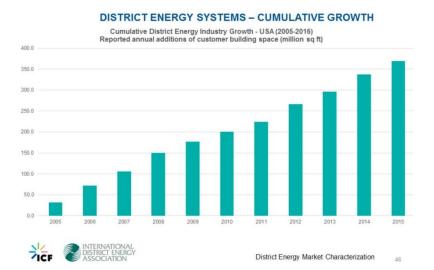

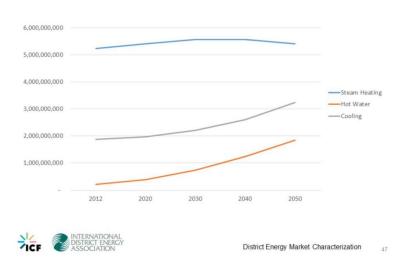

# **CA Regulation Pushing Onsite Non potable Reuse**

#### 1. San Francisco - Article 12C (2015)

 In 2015, Article 12C became a mandatory requirement for new development projects of 250,000 square feet or more of gross floor area to install and operate an onsite water reuse system.

#### 2. Menlo Park - Title 16, Section 16.43.140 (2018)

- This "green and sustainable building ordinance" requires all new buildings greater than 250,000 square feet to use an alternate water source for nonpotable applications.
- In the case that there is no recycled water purveyor available, the project will need to reduce potable demand by 30% compared to the City's water budget baseline.

#### Senate Bill No. 966

#### CHAPTER 890

An act to add Article 8 (commencing with Section 13558) to Chapter 7 of Division 7 of the Water Code, relating to water quality.

[ Approved by Governor September 28, 2018. Filed with Secretary of State September 28, 2018. ]

#### LEGISLATIVE COUNSEL'S DIGEST

SB 966, Wiener. Onsite treated nonpotable water systems.

Existing law requires the State Water Resources Control Board to establish uniform statewide recycling criteria for each varying type of use of recycled water where the use involves the protection of public health.

This bill would, on or before December 1, 2022, require the state board, in consultation with the California Building Standards Commission and the Department of Housing and Community Development, to adopt regulations for risk-based water quality standards for the onsite treatment and reuse of nonpotable water, as provided. The bill would authorize the state board to contract with public or private entities regarding the content of the standards. The bill would require a local jurisdiction, as defined, that elects to establish a program for onsite treated nonpotable water systems to, among other things, adopt, through ordinance, a local program that includes the risk-based water quality standards established by the state board. The bill would, on or before December 1, 2023, require the department, in consultation with the state board, to develop and propose for adoption any necessary corresponding building standards to support the risk-based water quality standards established by the state board. The bill would prohibit an onsite treated nonpotable water system from being installed except under a program established by a local jurisdiction in

- Requires local agencies to adopt guidelines and develop programs to permit onsite nonpotable reuse systems by 12/1/2023.
