I have reviewed the Legal Description (Exhibit A) and the Project Boundary map (Exhibit B) and have the following comments.

### Legal Description (Exhibit A)

The legal description, which describes the boundary of the Development Agreement, actually describes three (3) separate sites named **PARCEL 1** (east of Los Gatos Creek), PARCEL 2 (between Santa Clara and Lenzen), and PARCEL 3 (west of Los Gatos Creek, between Santa Clara and Auzerais).

The legal description contains **only** course information (bearings and distances) without any boundary details. Although the description is not a normal description that will transfer rights, it should contain at least a few streets so that it is apparent where the intent of the boundary line should follow.

Eg. "...along the southerly line of Santa Clara Street...", "...along the easterly line of Barack Obama Blvd, formerly know as South Autumn St...", "...to the most northwesterly line of Auzerais Street...".

The legal description courses also seem too detailed with too many minor jogs. However, Exhibit B seem very smooth in comparison and does not show all the jogs and curves as described in the legal. I believe they have a GIS shapefile that may be a better and simpler shape for the boundary. That should be used for the legal description.

At the end of the legal description for PARCEL 3, there is an exception clause for only Document 16434322 (APN 259-38-139). However, Exhibit B shows multiple parcels to be excluded that are not listed in the legal description exclusions. Per DA Recital, Section H (pg 10-11):

As reflected in <u>Exhibit B</u>, the Project Site for purposes of this Agreement also does not include certain property owned by the Pacific Gas and Electric Company (a portion of APN 261-35-002), certain property owned by the Peninsula Corridor Joint Powers Board (APN 261-34-020), or certain other property owned by VTA (APNs 259-38-139, 259-38-114, 259-38-134 [<del>NOTE-working with</del> VTA to include]),

I recommend that HMH revise the Legal Description to 1) ADD calls to Streets and Boundary lines, 2) simplify and match course information as shown on the Exhibit B parcel shapes, 3) provide a Closure Report for the Parcels, and to 4) add additional references for the Exception parcels that are to be excluded from the DA, shown on Exhibit B, but not described as an exception.

#### Project Boundary map (Exhibit B)


I recommend that HMH revise the Project Boundary Map to 1) label Streets and Boundary lines, 2) label each specific Parcel and its Point of Beginning (POB), 3) add additional feature information to the Legend, and 4) verify the additional references for the Exception parcels that are shown, but not included, in the Legal description.






