I have reviewed the two attachments and have the following comments.

#### Exhibit C2 Autumn Street Parcels-c

Per DA, this exhibit should be the *Site Plan and Legal Description* for **255 Autumn St**. (APN 259-29-020), **260 & 240 N Montgomery St** (APNs 259-29-012 & -103), that will be used in the <u>future fee</u> transfer to the City of San Jose.

However, the site plan is very basic and is more of a GIS location map. I suggest standard plat maps be developed by HMH, (that include Point of beginning, metes and bounds, etc) to be used for this exhibit and for the future fee transfer to the City.

There is no legal descriptions in this exhibit. I suggest HMH create new legal descriptions that represent the boundaries of the individual Autumn Street Parcels and include them in a revised Exhibit C2.

#### VTA Legal Descriptions-c


Theses legal descriptions are unrelated to Exhibit C2 and represent three (3) of the VTA owned parcels that are referenced in Section H of the Recital:

As reflected in <u>Exhibit B</u>, the Project Site for purposes of this Agreement also does not include certain property owned by the Pacific Gas and Electric Company (a portion of APN 261-35-002), certain property owned by the Peninsula Corridor Joint Powers Board (APN 261-34-020), or certain other property owned by VTA (<u>APNs 259-38-139, 259-38-114, 259-38-134</u>, which properties are included in the Downtown West Planned Development Zoning and General Development Plan, the Downtown West Design Standards and Guidelines, and the Vesting Tentative Map for the Project

However, I'm not sure if these "stand alone" legal descriptions are to be used as Exhibits in the DA. There is currently no specific reference in the DA for these parcels as an Exhibit. They do need to be added to the parcel exclusions in **Exhibit A** *Project Site Legal Description* but not as currently configured.

I have made this comment yesterday in the Exhibit A review, so hopefully HMH will either copy/paste these into the main Exhibit A, or somehow relabel these as sub-exhibits for the exclusion areas.
