The Kimley-Horn team would like to set up a call and discuss the applications both Google and the City of San Jose have submitted for large load interconnection at San Jose Substation A. The purpose of this call is to discuss the updated project boundaries of the Diridon Integrated Station Concept Plan (DISC: <https://www.diridonsj.org/disc>) and the possible impacts it may have to PG&E's San Jose Substation A.

Since customer information and applications for service represent confidential information, in order for all four parties to discuss the applications, PG&E requires that both Google and the City of San Jose provide PG&E written consent from an authorized representative to share each of their respective customer application information for the purposes of this call.

Action:

If you consent to the sharing of the customer information as described above, reply to this email stating:

- *Do you require a representative from your party be present on the call in order to exchange information?*

Once we receive this email from both parties, we can proceed with the DISC discussion.
