***SUBJECT: Diridon Station Area Update - City Council Meeting on May 25***

**May 20, 2021**

Hi Community Members,

The City has posted the materials for the virtual City Council meeting on Tuesday, May 25th, when the Council will consider approval of Google's Downtown West development project, the City's Amended Diridon Station Area Plan (DSAP), and the Diridon Affordable Housing Implementation Plan (AHIP).

Shortcuts to the materials are [available](#). We plan to update this webpage with the presentations at least 24 hours in advance of the meeting.

For the agenda, the Downtown West project will be heard first; it is listed as agenda item #10.2. The amended DSAP and AHIP will be heard concurrently; they are listed on the agenda as items #10.3 and #8.1. This means doing the presentations, public comment, and Council discussion/actions on Downtown West, then repeating that sequence for the Amended DSAP and AHIP.

The start time for the Downtown West item is listed as "not to be heard before 6:00 pm" on the Council agenda.

There will be Spanish and Vietnamese interpretation.
