Hi Nanci:

Sure, Bhavesh can join the meeting. This should not be a big deal, since the project as a whole and currently known, is covered by the EIR. To the extent that any subsequent housing development/proposal on the site (be it affordable or market rate) meets the criteria for subsequent review (e.g., conformance and consistency with checklist, GDP, DSG/D4D, etc.) as outlined in the EIR, there should be no problem. The real issue has to do with the characterization of infeasible alternatives, and the rationale for rejecting them. Hopefully Bhavesh has already spoken with ESA? Staff answers to his concerns are the same as what ESA would tell him.
