Please updated drafts of the Council Authorization, Encroachment Agreement (with insurance requirements) and Permit Checklist. These should be in near final form, subject to Google's review of the insurance provisions.

On another note, have you been able to confirm whether Google wants to proceed with the Streets & Highways vacation process? As we discussed with Ryan last week, the S&H process will raise a number of issues, but one that we didn't discuss was whether the County would accept for recording the Council vacation resolution. Per S&H 8325, the Clerk must certify the Council reso for recording. However, the current Vacation Reso does not contain the legal descriptions or maps that show the vacated area. Therefore, there will need to be a separate document prepared for recording, but I'm not sure whether the Clerk can certify that separate document as the Council resolution. We probably should discuss in more detail after you've had a chance to touch base with Google.
