Dear Ms. Frimann and Mr. Phan,

This letter supplements our letters of May 17, 2021 and May 20, 2021 concerning SSE's specific requests for changes to the Downtown West Mixed-Use Project documents. In the May 20, 2021 letter, we reserved further comments on construction mitigation until completion of our scheduled meeting on that topic with City staff, which occurred yesterday afternoon.

While we appreciate staff's efforts to keep us informed about the timeline and scope of discussions between the City and Google (and VTA), we continue to have serious concerns that the effects of these massive construction activities on SAP Center have not been adequately addressed. This is particularly disappointing given that we have spent so much effort over the past several years to inform the City and project sponsors of specific measures and criteria necessary to protect the Arena's unique operations and patron experience.

The Municipal Code requires that each Construction Impact Mitigation Plan (CIMP) be approved by the City Council. The CIMP proposed for adoption by the City Council with respect to the Project, however, is merely a template to be used at the Project horizontal, open space and vertical development stages. As currently proposed by the Project entitlements, the CIMPs for horizontal development will be subject to Conformance Review, while the CIMPs for open space and vertical development will not be reviewed until the building permit stage.

In order to allow for vital public input into all CIMPs, we request that the CIMP for each open space and vertical development also be required to be submitted and approved at the Conformance Review stage.

Furthermore, we request that each CIMP for the Project be subject to Arena protective criteria that would address such items as scheduling around major events, hours of activity within 1/3 mile of the Arena, equipment staging and construction worker parking, vehicular and pedestrian access, and more. We can work with City staff near-term on developing such Arena protective criteria for incorporation into the Project requirements.

Although SSE's construction management concerns go well beyond the matters described above, we believe that revising the entitlement documents to incorporate basic arena protection provisions, and to allow for greater public participation and input into the approval of CIMPs for vertical and open space development (in line with the procedures for horizontal development), are important steps in helping to ensure that SSE's unique needs will be taken into consideration. The changes requested above will also help meet the City's obligations under the AMA to coordinate with SSE regarding developments that could adversely affect transportation and parking near the Arena.

We look forward to discussing our requests with you at our meeting this afternoon. Please reach out to me if you wish to discuss any issues in advance.
