David: We did put in an inquiry yesterday with the NAHC and have not yet heard back. However, our understanding is that the Tamien Nation split off from another already established tribe, the Muwekma Ohlone, who were on the list of tribes included in consultation regarding Downtown West in October 2019 (Monica Arellano of Castro Valley). We do not have details about the split but are aware that the Tamien Nation chairperson is a knowledgeable tribal member. If the Tamien Nation is not currently on the NAHC list, we think it is likely that they will be added to the list at some point.

According to our archaeologist, the Cultural Resources section in the Draft EIR has all of the information available except the site records, which we can provide on a portable drive or via

an electronic link should you so desire.
